2017 Annual Meeting Business Meeting Minutes

51st Annual Meeting of the 63rd Infantry Division Association USAR

The 51st meeting of the 63rd Infantry Div (USAR) Association annual meeting took place at the Crystal Room of the Hotel Fullerton (Fullerton, CA) on 30 April 2017. It started with the social hour, allowing members to mingle and connect with old and new friends. It was then called to order by President (BG-Ret) Charles Ebner. The pledge of Allegiance to the Flag followed, led by MSG Harrison. Next, the Invocation was led by Chaplain (COL) Donald Forden. President Ebner then invited us to enjoy the buffet and begin our meal.

After the meal, the business meeting was started by the President. BG Ebner began by reminding us that the guest speakers for the meeting were ourselves. Each member was allotted 2-5 minutes to relate a special memory of their friendships, trials and tribulations as part of our Army Family. Afterwards, COL Wisenbaker took the podium for the meeting, awarding a life membership Certificate to LTC Brian Silk.

Afterwards, he proceeded to the call for nominations for Board Membership, both from the floor, and from previous Board Members, who stated that they were willing to continue.
